### Certificate of Insurance:

A Certificate of Insurance is required, in favour of, and showing both the Simcoe and District Chamber of Commerce and the Norfolk County Agricultural Society as Additional Insured. The Certificate of Insurance must apply from February 26, 2025, to March 3, 2024, inclusive and must contain a clause providing at least fifteen (15) days notice of cancellation or material change in policy.

Minimum coverage requirements are as follows: \$2,000,000.00 Commercial General Liability, including Products and Completed Operations Liability, Broad Form Property Damage, Occurrence Property Damage, Cross Liability, and Tenants Legal Liability (minimum \$10,000.00 limit this section). The Chamber shall use all reasonable precautions for the protection of the public and property but will not be responsible for any loss or damage by fire, theft, or otherwise, howsoever.
